INVITATION FOR PROPOSALS FOR THE PROVISION OF SEWERAGE REMOVAL AND TREATED EFFLUENT TRANSPORTATION SERVICES REF NO.: DTP/RFP/22/AGZ/10/2016

Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC has conservancy tanks and treatment works which handle waste water. The precinct currently generates an average of approximately 36kL of sewer water a day.

DTPC wishes to appoint a suitably qualified and experienced service provider to undertake the removal of raw sewer water generated from the Precinct and discharge it to primarily ACSA's SWWTW or to the nearest approved municipal waste water facility (Ottawa), for a period of one (1) to two (2) years.

The contract will have an element of Enterprise Development (ED) of a minimum of 35%. This is to be executed by historically disadvantaged companies which have at least 51% black owned. The ED element is designed to assist with the development and sustainability of black companies (i.e. EME and QSE) through participation and development within this contract.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system.
