## INVITATION FOR PROPOSALS FOR THE PROVISION OF COMPREHENSIVE WASTE MANAGEMENT SERVICES FOR THE DUBE TRADEPORT PRECINCT FOR A PERIOD OF THREE (3) YEARS REF: DTP/RFP/28/PRO/01/2017

Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop the Dube TradePort. Refer to [www.dubetradeport.co.za](http://www.dubetradeport.co.za) for more information on DTPC.

DTPC hereby invites proposals from competent service providers for the provision of comprehensive Waste Management Services for the DTP precinct for a period of 3 years.

The successful bidder will be required to provide waste management services for all waste streams including but not limited to recyclables, non-recyclables, hazardous waste and general waste for specified areas within the precinct viz. buildings, infrastructure, facilities and grounds.

The contract will have an element of Enterprise Development (ED) of a minimum of 35%. This is to be executed by historically disadvantaged companies which are at least 51% black owned. The ED element is designed to assist with the development and sustainability of black companies (i.e. EME and QSE) through participation and development within this contract.

### EVALUATION OF THIS BID

All proposals will be evaluated in various stages in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system.
