Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to [www.dubetradeport.co.za](http://www.dubetradeport.co.za) for more information on DTPC.

The AgriZone precinct at Dube TradePort Corporation is reliant on various climate and irrigation systems for their Greenhouse operations. DTPC intends to appoint a suitable authorised or licensed service provider (dealer) for a period of three years to:

- (i) Provide expert bi-annual servicing and audits and 24hour on-line support of the Priva and non-Priva systems for the AgriZone Greenhouses;
- (ii) Acquire all necessary parts for:
  - Priva – Climate and irrigation systems;
  - Ridder – Screen and vent drive systems;
  - Infa – Fogging and water disinfection systems;
  - Alweco – Screen Materials and parts;
  - Sotex – Heating Storage Tank pressure system; and
  - Certhon – Greenhouse structure parts

#### **EVALUATION OF THIS BID:**

All proposals will be evaluated in various stages including compliance, functionality and price in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system where 90 points will be reserved for price only and 10 points reserved for preference points as per the B-BBEE verification certificates or EME letters.
