Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC wishes to enter into a three year maintenance contract with a suitably qualified and experienced service provider who will ensure that all DTPC generators are maintained at an acceptable working standard.

There are 13 existing generators (Volvo, Perkins, Cummins, CAT, John Deere) ranging from 250 KVA to 1250 KVA and additional generators which will be incorporated in this contract. Effective proactive, predictive and preventative programmes must be implemented to minimise reactive maintenance.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system where 90 points will be reserved for price only and 10 points reserved for preference points as per the B-BBEE verification certificates or EME letters.
