## INVITATION FOR PROPOSALS FOR THE CONSTRUCTION OF TRADEZONE 1 - GUARDBOUSES AND ALTERATIONS TO THE EXISTING ROADS AT DUBE TRADEPORT REF NO.: DTP/RFP/17/IFR/09/2015

DTPC invites tenders from competent civil engineering and building contractor(s) for the construction of two (2) new Guardhouses and alterations to the existing roads at TradeZone 1. The works include, but are not limited to, road alterations and bus-stops, additions and alterations to the Trade House, and erosion protection measures at the MRO site.

The project will have an element of enterprise development as per the bid document. The contractor(s) must be registered with CIDB grading 7 CE/GB or higher by the date of evaluation of this bid.
