Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC intends constructing a Purpose built Biotech manufacturing facility (±12500 sqm) located at TradeZone 1b within the Dube TradePort precinct.

DTPC wishes to appoint a suitably qualified service provider (with experience in dealing with international manufacturing / production related operations and clientele) to assist with architecture, design, engineering, and construction supervision services, in consultation with an international consultant firm. This will include conceptual, preliminary and detailed designs, procurement assistance, construction supervision and close out reporting for the proposed development. The contract will have an element of Enterprise Development.

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2011 using the 90/10.
