Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC wishes to enter into a three-year contract with a suitably qualified and experienced refrigeration contractor who will ensure that the cold room plants are upgraded and maintained for a period of thirty six (36) months at an excellent working standard.

Only CIDB registered contractors with active status CIDB grading level of 3ME or higher will be eligible to tender.

The contract will have an element of Enterprise Development (ED) and pre-qualification criteria, which requires that bidders sub-contract a minimum of 30% of the contract to an Exempted Micro Enterprise (EME) company.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 preference point system where 80 points will be reserved for price only and 20 points reserved for preference points as per the B-BBEE verification certificates.
