2. Isingeniso

UMthetho Wokukhuthaza Ukufinyelela Olwazini (i-PAIA) uphoqelela ukuthi kushicilelwe umqulu we-PAIA oqukethe imininingwane yamarekhodi asezandleni zesikhungo sikahulumeni ukuze kubhekelelwe izicelo zokufinyelela olwazini.

I-PAIA yakhelwe ezihlinzekweni zeSigaba 32 soMthethosisekelo esithi wonke umuntu unelungelo lokufinyelela olwazini olusezandleni zoMbuso noma olugcinwe ngomunye umuntu, oludingeka ngenhloso yokusebenzisa kanye nokuvikela nanoma yiliphi ilungelo.

Izinhlolongqangi ze-PAIA ngokukhuthaza ukusebenza ngokusobala, ukuphendula ngezinto ezenziwayo kanye nokuphatha ngendlela efanele kuzo zonke izikhungo zikahulumeni kanye nezizimele. Lokhu kuhlomisa ngolwazi kuphinde kufundise abantu ukuba baqonde ngamalungelo abo angaphansi komthetho we-PAIA, abangawasebenzisa baphinde futhi bawavikele.

Lo mqulu wenziwe ngenhloso yokusungula izinqubo okumele zilandelwe kanye nemigomo okumele igcinwe ukuze umuntu akwazi ukufinyelela olwazini olusezandleni ze-Dube TradePort Corporation (DTPC).

3. Igunya le-DTPC

Umbono we-DTPC "ukuba yisikhungo esihamba phambili emhlabeni ekukhiqizweni nasekuthuthweni kwempahla ngamabhanoyi e-Afrika eseNingizimu, okudidiyelwe ngobunyoninco nengqalasizinda yezokuthutha emigwaqeni, ngezitimela kanye nezokuthutha zasolwandle".

3.2. IMPOKOPHELO

9. 1. Okudingekayo maqondana nokugcinwa kwemithetho

Ngokwezihlinzeko zoMthetho, ukufinyelela kumarekhodi acelwe e-DTPC ayonikezelwa kuphela uma:

- Kugcinwe yonke imigomo ye- PAIA emaqondana nesicelo; futhi
- Ukufinyelela kumarekhodi aceliwe kunganqatshwanga ngokwananoma yiziphi izizathu zokwenqatshwa kwesicelo ezibekwe kulo Mthetho.

9. 2. Inqubo elandelwayo uma kufakwa isicelo sokufinyelela erekhodini

Nazi izinyathelo okumele zithathwe uma kufakwa isicelo sokufinyelela erekhodini:

ISINYATHELO SOKUQALA (1): ISICELO

Uma umuntu efisa ukuthola ulwazi olugcinwe yi-DTPC, kufanele agcwalise ifomu lesicelo (**Isithathiselo 1**) bese elithumela koyiSekela leSikhulu Esibhekele Ulwazi (imininingwane yalesi sikhulu itholakala emqulwini we-PAIA wase-DTPC). Umfakisicelo kumele futhi acacise ukuthi ufuna ikhophi yerekhodi noma ufuna ukuyolibona ezakhiweni zakhona e-DTPC.

ISekela leSikhulu Esibhekele Ulwazi kumele lelekelele umfakisicelo esicelweni sokufinyelela erekhodini ngenhloso yokuqinisekisa isicelo siyahambisana nezimiso zoMthetho. ISekela leSikhulu Esibhekele Ulwazi alikwazi ukuvele lichithe isicelo uma singagcwalisiwe ngendlela efanele nangokuphelele. ISekela leSikhulu Esibhekele Ulwazi liyobe selazisa umfakisicelo ngenhloso yalo yokuchitha isicelo ngokusebenzisa iSaziso Sokungalandelwa kweNqubo. Esimweni esinjalo, umfakisicelo kuyomele alethe eminye imininingwane emaqondana nesicelo.

Ngokwezimiso zoMthetho, isicelo sokufinyelela erekhodini kumele sihambisane nemali eyisamba esingama-R35.00 uma isicelo singafakwanga ngumuntu ocela ulwazi olumaqondana naye siqu.

ISINYATHELO SESIBILI (2): UKUQINISEKISWA KANYE NOKWAZISWA UKUTHI ISICELO SITHOLAKELE

ISekela leSikhulu Esibhekele Ulwazi lamukela bese liqinisekisa isicelo ukuze lizanelise ukuthi irekhodi elicelwayo likhona e-DTPC. Emva kwalokho-ke isicelo sibe sesamukelwa, sichithwe noma sedluliselwe emnyangweni ofanele ukuze kutholakale irekhodi elicelwayo. Isicelo siyovunywa ngaphandle uma sihoxisiwe kumbe sichithiwe ngenxa yezizathu zokuchithwa kwesicelo ezidalulwe eSahlukweni 4 seNgxenywe 2 yoMthetho.

Kuyobe sekukhishwa isaziso ukuze kwazisa umfakisicelo ngemali yesicelo (uma idingeka); ngesimo sesicelo bese enikezwa nenombolo yesicelo sakhe.

ISINYATHELO SESITHATHU (3): UKULUNGISWA KWEREKHODI

Uma isicelo sivunyiwe, abase-DTPC bayobe sebehlanganisa irekhodi baphinde balilungise bese bebala izindleko okumele zikhokhwe.

ISINYATHELO SESINE (4): ISAZISO SOKUGCINA

Umfakisicelo uyokwaziswa uma isicelo sakhe sesiphothuliwe aphinde aziswe nangezindleko okumele azikhokhele i-DTPC.

ISINYATHELO SESIHLANU (5): INKOKHELO KANYE NOKUKHISHWA KWEREKHODI

Uma umfakisicelo esezikhokhile izindleko (ezibalulwe esiNyathelweni 4) (kubandakanya nendlela yokukhokha ebalulwe esiNyathelweni 1), uyobe eselinikezwa irekhodi alicelile.

9.3. Ulwazi Olujwayelekile

Izicelo zokufinyelela kumarekhodi agcinwe yi-DTPC ngokwegunya layo lokuba yisikhungo sikahulumeni kumele zenziwe kuphela ngokusebenzisa ifomu elinqunywe nguMthetho, ikhophi yalo efakwe yaba Isithasiselo 1 kulo mqulu. Uyakwazi ukuwuthola nge-PDF (uma ufuna ukuzibhalela ngesandla) ngaphansi kwesizindalwazi sakwa-DTPC.

Imithethonqubo kanye neSigaba 18 soMthetho kuphoqelela umfakisicelo ukuba anikeze lolu lwazi olulandelayo:

- Imininingwane yomuntu ocela ukufinyelela erekhodini;
- Umumo noma indlela afisa ukulithola ngayo irekhodi njengalokhu kuchaziwe eSigabeni 29;
- Imininingwane yerekhodi elicelwayo;
- Imininingwane yokuxhumana yomfakisicelo (ikheli/inombolo yefeksi/ikheli le-imeli);
- Incazelo yolimi afisa ukuthola ngalo irekhodi eliceliwe;
- Uma umfakisicelo ecela ulwazi egameni lomunye umuntu, kumele sichazwe isikhundla salowo ofaka isicelo egameni lomunye umuntu;
- Uma umfakisicelo efisa ukwaziswa ngesinqumo ngenye indlela ngaphezu kokwaziswa ngokubhalelwa, isibonelo, uma efisa ukwaziswa ngocingo, kumele ayicacise leyo ndlela; kanye
- Nendlela umfakisicelo afisa ukwaziswa ngayo maqondana nesinqumo esithathiwe ngesicelo sokufinyelela erekhodini alicelile.

Abafakizicelo abangakwazi ukufunda nokubhala bangenza izicelo ngomlomo koyiSekela leSikhulu Esibhekele Ulwazi lona-ke liyobe sesigcwalisa ifomu egameni lomfakisicelo bese linikeza umfakisicelo ikhophi;

Abase-DTPC bayozama ngokusemandleni abo ukunikeza irekhodi ngendlela okucelwe ukuba litholakale ngayo ngaphandle uma lokho kuyophazamisa indlela yokusebenza kwe-DTPC. I-DTPC iyocophelela ukulondolozeka kwamarekhodi kanye nokuvikela ilungelo lobunikazi bamarekhodi ngesikhathi kulungiswa irekhodi eliceliwe. Izimali zokufinyelela ezikhokhwayo ziyobalwa ngokwendlela umfakisicelo acela ngayo irekhodi ekuqaleni (Isigaba 29(3) kanye nesigatshana (4).

- Ulwazi oluthile olumaqondana nokusebenza kwesikhungo sikahulumeni.

I-DTPC ingazichitha izicelo ezibonakala ziwumdlalo noma eziyinkathazo kumbe eziyoholela ekusetshenzisweni kwezinsizakusebenza ngendlela engenambuyiselo.

9.4.2. UKUDALULA OKUYIMPOQO OKUZUZISA UMPHAKATHI

Ngaphandle nje kwananoma yisiphi esinye isihlinzeko esiku-PAIA, iSekela leSikhulu Esibhekele Ulwazi kumele lisivume isicelo sokufinyelela erekhodini lase-DTPC uma –

10.2 Ukwasiswa ngezimali ezikhokhwayo
