DTPC is currently in the process of constructing a 3000sqm purpose made catering facility within the precinct known as the TradeZone.

DTPC invites proposals from suitable qualified and experienced service providers to supply the 315kVA diesel generator to serve as back up supply to the tenants in the event of a power failure.

This will include:

- Installation of a sound proof door and louvre system
- Compliance to SANS regulations/specifications and any other regulation / specification that may apply to this contract
- Electrical Contractor shall carry out his own testing to ensure that the installation complies with all relevant bylaws
- Maintenance plan (including two year service and maintenance)

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2011 using the 80/20.
